#### *Course Description*

To gain necessary life skills in society such as a hunger for knowledge, how to gain knowledge and continuously seek further self-development; be able to use technology efficiently; apply reasoning, analytical thinking, problem-solving, and negotiation skills; learn the principles of self-management, emotional control, and stress management; to develop oneself to have morality, ethics, proper human relationships, manners and etiquette.

### 10111 English for Communication

(6 credits)

#### *Course Learning Outcomes*

1. To be able to use English as a means for communication.
2. To study structures, vocabulary and important English idioms.
3. To equip students with skills in listening, speaking, reading and writing in English for accuracy and appropriateness in various situations

#### *Course Description*

Structure, vocabulary and English idioms used in listening, speaking, reading and writing English for communication.

### 10121 Human Civilization

(6 credits)

#### *Course Learning Outcomes*

1. To have knowledge on Eastern and Western civilization in terms of politics, economy, and society.
2. To understand human civilization in the past which is fundamental of the current civilization.
3. To realize and appreciate the values of human civilization.

#### *Course Description*

Knowledge on Eastern and Western civilization human has created in terms of politics, economy, society, wisdom, arts, as well as science and technology.

### 10131 Human Society

(6 credits)

#### *Course Learning Outcomes*

1. To understand the existence of human community and society.
2. To understand the political, legal, economic and social mechanisms affecting an organization of human society.
3. To promote the responsibility to the society and nation.

**Course Description**

Basic characteristics of being human; cohesion into communities and societies; human distribution and settlements; the components of society; human behavior in society; political, legal, economic and social mechanisms affecting the organization of human society; social problems and methods to solve them; promotion of a good society.

**10141 Science, Technology and Environment for Life****(6 credits)****Course Learning Outcomes**

1. To gain knowledge about the concepts, rules and development of science and technology, and how they influence of thought and human livelihood.
2. To gain knowledge about the evolution of living things and human beings.
3. To understand the relationship between humans, the environment, and the effects of science and technology on the environment.
4. To gain knowledge of the applications of science, technology, and mathematics in daily life.
5. To enhance scientific thinking and awareness of the need for environmental preservation.

**Course Description**

Concepts, theories, critical thinking, rules and development of science and technology; natural history concerning human beings; the parts of the human body; humans and the environment; hygiene and nutrition; the application of science, technology, and mathematics in everyday life.

**10151 Thai Studies****(6 credits)****Course Learning Outcomes**

1. To learn about Thailand's history, society, language and culture.
2. To be able to apply the course knowledge to daily life.
3. To understand and take pride in what it means to be Thai.

**Course Description**

Knowledge about Thai in terms of history, settlement, politics, economy, culture, religion and ritual, language and literature, arts and culture.

**10152 Thailand and the World Community****(6 credits)****Course Learning Outcomes**

1. To be able to gain knowledge on situations, trends and characteristics of economic, social and political relations and changes in the world community which affect Thailand.
2. To gain knowledge on the status of Thailand in the world community.
3. To be able to analyze the problem as a result of globalization in various aspects including political, economical, social and culture and impact on moral and ethic.

**Course Description**

Status of Thailand in social world; dynamic of social changes which affecting Thailand; problems and causes of problems arising as a result of globalization which cause the awareness, knowledge and understanding of the situation; be able to analyze the cause of problem and the impact of Thai society in various aspect including political, economic, social, moral and ethical.

**10161 Thai for Communication****(6 credits)*****Course Learning Outcomes***

1. To be able to use Thai language as a tool for communication.
2. To improve language skill for communicate effectively and creatively.
3. To be able to use language in daily life and to pursuit of knowledge.

***Course Description***

Significance of language, idea and communication; the art of using word, sentence, idiom, phrase; development of listening, speaking, reading and writing skills to communicate effectively and creatively; using Thai language in daily life to pursuit of knowledge and transfer knowledge.

**10162 Chinese for Communication****(6 credits)*****Course Learning Outcomes***

1. To gain knowledge about Standard Chinese phonology, Mandarin phonetic alphabet (Hanyu Pinyin), and be able to write and pronounce the alphabet correctly.
2. To gain knowledge about Chinese characters--as basic words or assembled ones--and sentence structure and grammar for general communication, including practice with writing Chinese characters.
3. To be able to use Chinese in everyday life.

***Course Description***

Standard Chinese phonology, Hanyu Pinyin transcription, basic words, and dialogues for everyday use, structural grammar, and learn and practice writing of 550 Chinese characters.

**10163 Khmer for Communication****(6 credits)*****Course Learning Outcomes***

1. To possess knowledge on the phonology, letters, grammatical structure and basis sentence structure of Khmer.
2. To be able to use basic Khmer for communication in daily life.
3. To possess knowledge on Khmer words used in the Thai language.

***Course Description***

Khmer phonology; the practice of writing the Khmer alphabet; Crieng and Mul alphabets, basic Khmer words used in daily life; grammatical structure and basic sentence structure; listening, speaking, reading and writing skills for communication at the basic level; and Khmer words used in Thai language.

**10164 Social and Culture in the ASEAN Community****(6 credits)*****Course Learning Outcomes***

1. To be able to understand ASEAN background and history.
2. To be able to understand the purpose of the integration of ASEAN member states.
3. To be able to understand social and cultural condition of ASEAN member states.
4. To be able to understand the role and relationship of ASEAN and other nations.

***Course Description***

ASEAN background and history; the integration of ASEAN member states; social and cultural condition of ASEAN member states; the role and relationship of ASEAN and other nations.

**40101 General Principles of Law****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding as to the meaning of the law, history of law, as well as legal opinions.
2. Learners are equipped with knowledge and understanding on philosophy of law, legal systems, sources of laws, and legal interpretation.
3. Learners are equipped with knowledge and understanding on the basis of laws, laws relating to lifestyles, careers in the legal fields, as well as roles and ethics of lawyers.

***Course Description***

Meaning and characteristics of laws, history of legal notions, and schools of laws, different concepts and theories in philosophy of laws, understanding on the rationale and philosophy behind rules and regulations, sources of laws, hierarchy of laws, application and interpretation of laws, relationships between different categories of laws, and relationships between law and other related disciplines, laws relating to lifestyles, careers in the legal fields, roles of the law in societies, as well as ethics of lawyers.

**41214 Civil Law: Persons, Juristic Acts and Obligations****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the laws relating to the initiation until the termination of the nature of a person, competence and domiciles of persons and juristic persons.
2. Learners are equipped with knowledge and understanding as to juristic acts, expression of intention, void acts, voidable acts, conditions, temporal conditions, time period, and statute of limitations.
3. Learners are equipped with knowledge and understanding on laws pertaining to general principles of contracts, down payment, and contractual penalty.
4. Learners are equipped with knowledge and understanding on laws relating to obligations, subject of obligations, effect of obligations, subrogation, transfer of claims, assertion of claims by debtors, revocation of fraudulent acts, right of retention, preferential rights, multiple debtors and creditors, and termination of obligations.

***Course Description***

The initiation and termination of the nature of persons, competence, domiciles, juristic persons, juristic acts, void acts, voidable acts, conditions, temporal conditions, time period, statute of limitations, general principles of obligations, down payment, contractual penalty, obligations, subject of obligations, subrogation, transfer of claims, assertion of claims by debtors, revocation of fraudulent claims, right of retention, preferential rights, multiple debtors and creditors, and termination of obligations.

**41215 Civil Law: Delicts and Property Law****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the laws relating to tort, management of affairs without mandate, and unjust enrichment.
2. Learners are equipped with knowledge and understanding on the meanings and types of property and asset, as well as acquisition of immovable property or property rights pertaining immovable property.
3. Learners are equipped with knowledge and understanding on the laws relating to revocation of registration to transfer immovable property or property rights pertaining immovable property, ownership, right of possession, and servitude.

4. Learners are equipped with knowledge and understanding on the laws relating to right of habitation, superficies, usufruct, and charge on immovable property.

***Course Description***

Tort, management of affairs without mandate, meanings and types of property and assets, acquisition of immovable property or property rights pertaining immovable property, revocation of registration to transfer immovable property or property rights pertaining immovable property, ownership, right of possession, and servitude, superficies, usufruct, and charge on immovable property.

**41216 Criminal Law: General Principles, Offenses and Petty Offenses**

**(6 credits)**

***Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the nature of criminal law, punishment, and general principles of culpabilities under criminal law.
2. Learners are equipped with knowledge and understanding on the elements in each offence under the Criminal Code.
3. Learners are able to determine wrongdoings and offences under the Criminal Code.

***Course Description***

Theories of criminal liabilities, nature of criminal laws, wrongdoings, and sanctions of various types under the Criminal Code, Chapters on General Provisions, Offences, and Misdemeanors, as well as theories on how to correct behaviors of wrongdoers so that they can be reintegrated into other law-abiding citizens.

**41217 Principles of Public Law and Constitutional Law**

**(6 credits)**

***Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the meanings, basic philosophy of public law.
2. Learners are equipped with knowledge and understanding on the state, state institutions, and juristic persons under public law.
3. Learners are equipped with knowledge and understanding on the evolution and meanings of the Constitution.
4. Learners are equipped with knowledge and understanding on the concepts relating to human rights, as well as rights and liberties.
5. Learners are equipped with knowledge and understanding on regimes of governance, check and balance system on the exercise of state power, as well as the Constitutional Court and procedures in the Constitutional Court.

***Course Description***

Meaning of public law, basic philosophy of public law, separation of private law from public law, elements and forms of state, existence of different juristic persons and state institutions, sources of public law, basic principles and legal procedures in public law.

History and evolution of the Constitution, meaning of constitution, concepts relating human rights, civil rights and liberties, as well as the protection of civil rights and liberties, regimes of governance, different organizations of the state, allocation of sovereign power, guarantee of security under the Constitution, check and balance system on the exercise of state power, the Constitutional Court and procedures in the Constitutional Court.

**41218 Commercial and Business Law I****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the criteria of the Civil and Commercial Code in Chapter III on Specific Contracts, from sales agreement, exchange, giving, lease of property, hire-purchase, hire of services, hire of work, borrowing, deposit, agents, brokers, and insurance.
2. Learners are able to apply their knowledge to determine emerging issues, facts, and put them into implementation.

***Course Description***

Concepts and theories relating to commercial and business contracts, sales agreements, sales of specific items, exchange, giving, lease of property, hire-purchase, hire of services, hire of work, borrowing, deposit, agents, brokers, and insurance.

**41311 Civil Law: Family Law and Law of Succession****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the laws on family and succession.
2. Learners are able to apply knowledge to determine issues, emerging facts, and put them in implementation.
3. Learners understand the principles and rationale on each topic of the laws, emphasizing on relationships among those laws and their impact on the society.

***Course Description***

Family law, ranging from betrothal, marriage, relationships between husbands and wives, property between husbands and wives, validity of marriage, termination of marriage, rights and duties of fathers, mothers, and children, guardianship, adopted children, as well as amount of maintenance.

Law on succession, ranging from succession of the estate, the status of descendants, statutory rights of inheritance, allocation of the estate, division of shares among statutory heirs of different classes and degrees, acquisition of the estate per stirpes, status of heirs by testaments, forms of testaments, consequence and interpretation of testament, validity of testament or testament clauses, methods of management and allocation of the estate, unacquired estate, and statute of limitations in cases concerning the estate.

**41312 Civil Procedure****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the Law on the Organization of the Court of Justice, and the Civil Procedure Code.
2. Learners can apply the knowledge to determine and apply the facts to related laws.

***Course Description***

General principles relating to procedures of private law, criminal, public law, the Law on the Organization of the Court of Justice, and the Civil Procedure Code, ranging from jurisdictions in civil cases, objection of judges, power and duties of the courts, courtroom hearing, reports and case files, parties, filing and submission of pleadings, judgments and orders, and fees, ranging from general procedures in the Court of First Instance, specific procedures in the Court of First Instance, including procedures for petty offences, temporary measures before the judgments, trial by default and arbitration, procedures at the stage of Appeal and Supreme Courts.



**41313 Criminal Procedure and Law of Evidence****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on criminal procedure laws, forensic science, procedures in the Kwaeng Court and the Juvenile and Family Court.
2. Learners are equipped with knowledge and understanding on the law of evidence.
3. Learners can apply the knowledge to determine and apply the facts to related laws.

***Course Description***

General principles of criminal procedure, procedure before filing criminal charges, injured persons, jurisdiction, subpoena, criminal warrants, arrest, search, detention, confinement, imprisonment and release, investigation, prosecution, autopsy, filing of criminal charges, preliminary examination, and trials in the Court of First Instance, judgments, orders, appeals and final appeals, execution of judgments, fees, pardon, commutation, reduction of sentences, forensic science, procedures in the Kwaeng Court and the Juvenile and Family Court.

General principles of the law of evidence, challenges in court cases, burden of proof, duty to adduce evidence, selection of evidence, methods of adducing evidence, admission and weighing of evidence in both civil and criminal cases.

**41314 Commercial and Business Law II****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the criteria of the Civil and Commercial Code in Title III on Specific Contracts ranging from insurance, mortgage, pledge, current accounts, bill of exchange, partnership, limited companies, commercial contracts, and other businesses.
2. Learners are able to apply their knowledge to determine emerging issues, facts, and put them into implementation.

***Course Description***

Insurance, mortgage, pledge, current accounts, bill of exchange, partnership, limited companies, commercial contracts, and other businesses.

**41315 Alternative Dispute Resolution****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the principles, evolution of alternative dispute resolution, nature and various forms and types of alternative dispute resolution.
2. Learners are equipped with knowledge and understanding on different treaties, laws, and criteria relating to alternative dispute resolution.
3. Learners are aware of the roles of different organizations relating to alternative dispute resolution.

***Course Description***

Principles and evolution of alternative dispute resolution, nature and various forms and types of alternative dispute resolution, as well as international laws, domestic laws, criteria, and organizations or relevant domestic and international institutions.

**41316 Taxation Law****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the theory of tax, the relationships between tax and economic systems, and also understand the laws relating to personal income tax, and corporate income tax.
2. Learners are equipped with knowledge and understanding on the theory of indirect tax and property tax, and understand the objectives and policies on how to collect indirect tax and property tax.

***Course Description***

The theory of tax, roles of tax, and designs of tax policies connected with economic systems, personal income tax and corporate income tax of Thailand, as well as the Double Taxation Treaty between Thailand and other countries.

The theory of indirect tax and property tax, legal principles and methods to collect indirect tax such Value Added Tax, specific business tax, revenue stamps, excise tax, customs tax, and property tax.

**41317 Execution and Bankruptcy Law****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the laws relating to legal execution in civil cases.
2. Learners are equipped with knowledge and understanding on insolvency law.
3. Learners are able to apply their knowledge to determine and apply the facts to the related laws.

***Course Description***

General principles on legal execution, asset seizure, attachment, preferential claims for the repayment of debt, request for the release of property, application to separate one's share of his/her assets, application to allow one to participate in the property, the withdrawal and abstention of legal execution, auction and repayment of debt to debtors, principle of bankruptcy and business-reorganization laws.

**41318 Law of Social Welfare, Health and Medical Laws****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the concepts, principles, and laws relating to social welfare, public health and medicine.
2. Learners are able to apply their knowledge acquired in their line of work and in their lifestyles in the society.

***Course Description***

Concepts, principles, state policies and laws relating to social welfare, social welfare system, arrangement of welfare to different types of persons in the society, issues relating to welfare arrangement and its solutions

Fundamental concepts relating to health laws, structuring of public and private organizations relating to health system, the country's health policies, health insurance system, dispute resolution system, redress, and compensation of damage incurred from health services, as well as legal issues relating to health system.

Legal concepts and principles relating to medical personnel, liability of medical personnel, and ethic scrutiny for medical personnel.



**41319 Communication and Technology Law****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the emerging laws relating to technology and communications.
2. Learners are equipped with knowledge and understanding on the civil, criminal, and public laws relating to technology and communications in connection with politics, economy, and society.
3. Learners are able to apply their knowledge acquired in their line of work and their lifestyles in the society.

***Course Description***

Relationships between the laws and technology and communications, concepts, and legal development relating to technology and communications, structure, roles and duties of state organs, and civil, criminal, and public laws relating to technology and communications in connection with politics, economy such as radio-television, telecommunications, banking, electronic commerce, social media, cybersecurity, personal data, intellectual property relating to technology, information and communications, roles and duties of state officials, electronic evidence etc. and developmental effect on technology and Thai laws.

**41320 Land Law****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding in different criteria relating to land according to land laws, laws on land allocation, laws relating to land reform for agriculture, and other laws relating to land.
2. Learners are able to apply their knowledge to determine emerging issues or facts relating to land.
3. Learners understand and are aware of the importance and necessity of laws and the overall state and social mechanisms, as well as understand each topic of the principles and rationale of the laws relating to land.

***Course Description***

Land law, ranging from land system, state and private land, land allocation for the people, the issuance of land rights document, land measurement, registration of rights and juristic acts, the determination of rights in the land for religion, aliens' rights, and certain types of juristic persons' land, land allocation, land reform for agriculture, land allocation for occupation, land allocation for area development, land development, land lease for agriculture, as well as other laws relating to land.

**41401 English for Lawyers****(6 credits)*****Course Learning Outcomes***

1. Students acquire the knowledge and understanding about vocabularies and legal English idioms.
2. Students can read and understand articles or legal texts in English.

***Course Description***

General English legal vocabulary and terminology for the purpose of reading and comprehending legal texts written in English.

**41402 Thai and Foreign Legal Systems****(6 credits)*****Course Learning Outcomes***

1. Students acquire the knowledge and understanding about major foreign legal systems which influence world legal systems and Thai laws as a basis of understanding for the research studies of foreign laws and comparative legal studies.
2. Students acquire the knowledge and understanding about the history and evolution of the Thai legal system.

***Course Description***

Historical evolution of important legal principles; judicial systems; the influence of major foreign legal systems.

Historical evolution of the Thai legal and judicial systems from the Sukhothai period to the present time with an emphasis on legal reform and the administration of justice during the reign of King Rama V, and the codification of laws in subsequent periods.

**41403 Law and Social Change****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the content of law subject as connected to other subjects, and connected to socio-cultural dynamics on politics, economy, society, science and technology.
2. Learners are able to apply their knowledge acquired for further education, career, or country development.

***Course Description***

General principles on relationships between law and society, with constantly-evolving social dynamics and relationships covering politics, economy, society, science and technology such as politics and governance, legal binding effect, justice system, business, transportation, fund flows and international trade, information technology, environment, consumer protection, anti-dumping, competition law, education, public health, social welfare for the elderly etc.

Application of laws for the development and consistency with fast-moving and ever-changing socio-cultural environment.

**41404 Labor Law****(6 credits)*****Course Learning Outcomes***

1. To acquire the knowledge and understanding about principles and basic concepts and evolution of labour and social security laws.
2. To acquire the knowledge and understanding about various principles of labour protection laws and labour relations laws.
3. To be able to apply the acquired knowledge to solve problems or facts and implement them.

***Course Description***

Background and general theories of labor law and social security law; the Thai Labor Protection Law and its provisions concerning the fundamental rights and duties of employers and employees; the Labor Relations Law and its provisions concerning the relationship between employers and employees; establishment of employers' and employees' organizations in the forms of employers' associations or labor unions; workers' compensation law; social security law and law on labor relations in state enterprises, as well as procedures for the settlement of labor disputes by administrative agencies and the Labor Court.

**41405 Environmental Law****(6 credits)*****Course Learning Outcomes***

1. Students acquire the knowledge and understanding about the environment towards the society.
2. Students learn about the general principles of constitutional law on the environment, environment law and legal environment.
3. Students study the environmental law relating to the pollution control, the conservation of environment, the preservation of ancient monuments, ancient objects and nature as well as refrain from any acts which emit pollution and hazardous waste and compensation in environment-related lawsuit.
4. Students understand the requirement for the report on the analysis of environmental impact and the energy-related laws.

***Course Description***

The environmental crisis and its effects on global ecology; laws concerning environmental protection and conservation including pollution control and conservation of the environment and nature with emphasis on existing laws, government policies protecting citizens, rights to live in a suitable environment, and standards concerning claims for damages in environmental cases.

Law concerning the control of land utilization and city planning laws.

**41423 International Transaction Law****(6 credits)*****Course Learning Outcomes***

1. Students acquire the knowledge and understanding about the introduction to the principles of international trade.
2. Students acquire the knowledge and understanding about practices of international trade.
3. Students can apply the acquired knowledge to do business.
4. Students can solve the legal problems on international trade.

***Course Description***

Sources of international transaction law, basic criteria for application of import and export of goods in Thailand, policy and regulation on control of import and export of goods in Thailand and international groups such as ASEAN countries, common European market, East European group, currency control, appointment of foreign commercial agency, monopoly and control, restriction of trading.

Criteria of agreement and liability of contracting parties in international sale contract such as CIF, C&F, FOB contracts, grant of commercial credit and payment of goods, carriage of goods, marine insurance, applicable law in international commercial contract and international commercial dispute settlement mechanism.

**41431 Criminal Justice Administration****(6 credits)*****Course Learning Outcomes***

1. Students understand the duties of agencies in the justice process.
2. To provide students with the foundational knowledge about the justice process work, as the integrated administration system.
3. To enhance the concepts of the principle of coordination and campaign on the crime in the agencies, justice system and the society as a whole.
4. To make students and interested persons realize the role and importance of agencies in the justice system process which affect the well-being of the people and national stability.

**Course Description**

Administration of the entire criminal justice system comprising the police, lawyers, prosecutors, courts, prisons, probation and parole; coordination of work and the role of the public in the criminal justice system; concordance between administration of the judicial system and social changes.

**41444 Professional Experience in Law****(6 credits)****Course Learning Outcomes**

1. Learners are equipped with knowledge and understanding on major principles of legal career, trial advocacy and court proceedings, and are aware of morality and ethics for lawyers.
2. Learners are able to draft and review contracts, testaments, rules, regulations, and notifications relating to the laws, as well as to provide basic legal advice on tax planning.
3. Learners understand principles and rationale of dispute resolution and class action.

**Course Description**

General principles of legal career, morality and ethics for lawyers, trial advocacy and court proceedings, drafting and reviewing contracts, testaments, tax and its planning, rules, regulations, and notifications relating to the laws, dispute resolution, class action, and group activities.

**41451 International Law****(6 credits)****Course Learning Outcomes**

1. Students acquire the basic knowledge about the theories and principles of international laws as well as the enforcement of international laws.
2. Students acquire the knowledge and understanding about the conflict of law, nationality law and extradition.
3. Students can apply the acquired knowledge to solve the actual problems or facts and implement them.

**Course Description**

Characteristics and sources of international laws; relationship between international and national laws; subjects of international law; rights and duties of states; border and territorial sovereignty of states; treaties; settlement of international disputes; war and neutrality.

Characteristics of personal nationality; acquisition and termination of Thai nationality; conflicts of law.  
International co-operation in crime suppression and extradition.

**41452 International Institutes****(6 credits)****Course Learning Outcomes**

1. Students acquire the knowledge and understanding about the country and powers and authorities of various international institutions.
2. Students understand the role of current international organizations.

**Course Description**

Operational aspects and power of different international organizations such as UN organizations, governmental and non-governmental organizations including international charitable organizations such as the Red Cross.

**41454 Human Rights Law****(6 credits)*****Course Learning Outcomes***

1. To acquire the knowledge and understanding about the concepts, evolution and legal principles on universal human rights and human rights laws in Thailand.
2. To acquire the knowledge and understanding about the mechanism of human right protection at international and national level.
3. To apply the knowledge and understanding about human rights law at international and national level to solve the actual problems.

***Course Description***

Concepts and development of human rights; nature of international human rights; promotion and protection of human rights by the United Nations, regional international organizations and non-governmental organizations; mechanisms for protection of human rights in Thailand; rights and liberties of individuals such as liberty of the person, right to fair justice, freedom of conscience and right to privacy, as well as political, economic and cultural rights; rights of a person whose rights are at risk of infringement; civil rights; law, humanity and rights regarding refugees; trends in human rights.

**41455 Intellectual Property Law****(6 credits)*****Course Learning Outcomes***

1. To acquire the knowledge and understanding about the concepts and evolution of intellectual property protection and international laws on the protection of intellectual property.
2. To acquire the knowledge and understanding about categories of rights, protection and breaches of various intellectual properties protected under the Thai laws or which require further implementation legislation pursuant to the obligations of World Trade Organization.
3. To acquire the knowledge and understanding about the Intellectual Property Court and international trade and enforcement of intellectual property.
4. To apply the acquired knowledge and understanding about the three objectives to solve the problems concerning intellectual property rights.

***Course Description***

Historical evolution and important principles of law on copyrights, trademarks, patents, trade secrets, and unfair competition; international agreements on protection of intellectual property; protection of plant varieties; protection of integrated circuits; court procedures on intellectual property cases.

**41456 Consumer Protection Law and Competition Law****(6 credits)*****Course Learning Outcomes***

1. To acquire the knowledge and understanding on the concepts and principles on consumer protection.
2. To acquire the knowledge and understanding and to be able to explain the measures and mechanism and regulations on consumer protection and remedy of aggrieved consumers.
3. To acquire the knowledge and understanding and to be able to explain about the trade competition laws.
4. To acquire the knowledge and understanding and to resolve problems relating to the laws and protective measures for trade competition.

***Course Description***

Consumer Protection Law and Competition Law seeks to protect the quality of goods and services, price, labeling, packaging, parcel, advertising, organization and institution which are in charge of consumer protection pursuant to Consumer Protection Act and other relevant laws as well as principles, mechanism, measures, legal principles related to commercial competition by preventing business merging or cartel or limit competition, market abuse which may constitute a monopoly or unfair competition.

**41458 Business Crime****(6 credits)*****Course Learning Outcomes***

1. To acquire the knowledge and understanding on the meaning of business crime.
2. To acquire the knowledge and understanding on criminal liability in connection with business.
3. To acquire the knowledge and understanding on the laws on financial crime.
4. To acquire the knowledge and understanding about measures and mechanism for the suppression of business crime.

***Course Description***

Meaning of business crime, criminal liability in connection with business, laws on business crime, governmental crime prevention measures and mechanism with emphasis on money-laundering regulations.

**41460 Investment Law****(6 credits)*****Course Learning Outcomes***

1. To have fundamental knowledge regarding concepts, theories, and the substance of investment law.
2. To understand legal patterns, procedures, and means of different kinds of trade and investment.
3. To be able to apply the knowledge and understanding about investment law to consider before investing or doing investing activities.

***Course Description***

Concepts, theories, and the substance of investment law for various types of business including role, duties, and liabilities of entrepreneur, rules, regulations, orders, approaches and procedures as stated in the laws, entrepreneur's rights, and the change tendency of business and investment entities.

**41461 Administrative Law****(6 credits)*****Course Learning Outcomes***

1. Learners are equipped with knowledge and understanding on the sources and basic principles of administrative law.
2. Learners are equipped with knowledge and understanding on the structuring of state organizations, power and duties, liabilities and scrutiny of the administrative authorities.
3. Learners are able to apply their knowledge and understanding in their line of duty.

***Course Description***

Sources of administrative law, basic principles of administrative law, the organization of public administration, actions of the administrative authorities, the procedures in administrative cases, public services, the principles of personnel and asset management of the administrative authorities, the principles of liability of administrative authorities, scrutiny of administrative authorities, laws relating to public information, the Administrative Court and procedures in the Administrative Court.



**41462 Public Finance Law****(6 credits)*****Course Learning Outcomes***

1. To provide students with the knowledge and understanding of basic theories and concepts of monetary and fiscal law, monetary and fiscal policies, as well as the establishment of public finance organizations.
2. To provide students with the knowledge and understanding of revenue and expenditure of the government, the public debt structures, and the stage of budget process.
3. To provide students with the knowledge and understanding about public spending control and audit, and the monetary and fiscal control.

***Course Description***

This course addresses the background, theories and basic concepts of monetary and fiscal law, monetary policies, fiscal policies, public finance organizations, government revenue and expenditure, public debt, budget process, the government spending audit, and the monetary and fiscal control in various forms.

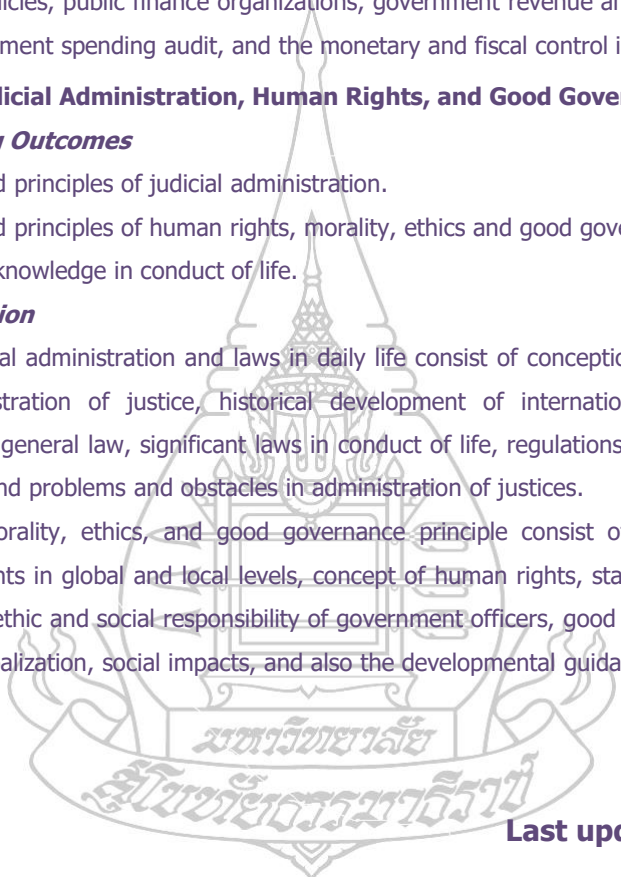
**41463 Principles of Judicial Administration, Human Rights, and Good Governance****(6 credits)*****Course Learning Outcomes***

Principles of judicial administration and laws in daily life consist of conception, principles, definitions of civil and criminal administration of justice, historical development of international administration justice, fundamental knowledge of general law, significant laws in conduct of life, regulations of social and country, rule of law, alternative justice and problems and obstacles in administration of justices.

Human rights, morality, ethics, and good governance principle consist of human rights, roles and development of human rights in global and local levels, concept of human rights, state policies affecting human rights, moral conceptions, ethic and social responsibility of government officers, good governance conduct, moral problems in the age of globalization, social impacts, and also the developmental guidance of moral and ethic.
