40701 Contract Law, Tort Law, and Advanced Comparative Law (6 credits)

Comprises 2 courses of 3 credits each

41701-1 Advanced Contract Law and Tort Law

Objectives

1. To have the requisite knowledge and understanding of the basic principles of contract law, tort law, and wrongful acts as well as of Thai legal system to conduct a comparative study of to the important aspects of contract and tort law.
2. To be able to solve the legal problems in contract law and tort law and wrongful acts suits.
3. To be able to analyze legal issues and propose guidelines for the amendment of contract law and tort laws.

Course Description

The basic principles of civil law—namely, good faith, good order, consent—determine the civil relationships concerning a breach of contract and restitution (unjust enrichment). They are also the sources of the principle of equity and of trust law, affecting the formation of contracts, specific performance, offers (deposit, contractual penalty, liquidated damages), remedies for breach of contract, the termination and expiration of contracts. They are principles of the common law system and the intended objective of the civil law system, force majeure.

Important related legal principles include the state of mind of an actor, the relationship between acts and strict liability, compensation, punitive damages (as a result of insurance and class action settlements), restitution, and unjust enrichment.

41701-2 Advanced Partnerships Law

Objectives

1. To have knowledge and understanding of the concepts and theories of law concerning partnerships, companies, and business organizations and to solve problems related to partnerships and company law.
2. To explore the legal measures related to the issues of partnerships, companies, and business organizations.
3. To be able to analyze relevant legal issues and propose guidelines for the amendment of law related to partnerships and companies.

Course Description

Legal principles of partnerships and companies, legal theories related to partnerships, companies, and business organizations in various forms, including aggregate theory, dominant theory, and roles of management, partners, and shareholders. Takeovers, mergers, acquisitions, and the ultra vires doctrine. Relationship between business organizations and comparative study of the common law system and civil law system as they relate to partnerships and companies.

41703 Law on International Trade and Investment

(6 credits)

Comprises 2 courses of 3 credits each

41703-1 Law on International Trade

Objectives

4. To have knowledge and understanding about law and theory on trade.
5. To have knowledge and understanding about legal principles and practices of international payments.
6. To have knowledge and understanding about legal principles and practices of international sale contract and the use of INCOTERMS.
7. To have knowledge and understanding and to be able to explain about legal principles and practices of international transport and insurance.
8. To have knowledge and understanding and to be able to resolve and analyze problems related to international trade.

Course Description

Law on international business operation and private trade, international sale of goods, Convention on International Sales of Goods, INCOTERMS, sales and paperless transaction, E-Commerce, import-export, methods of international payments such as letter of credit, international maritime transport, delivery certificate, international transport, maritime insurance.

41703-2 Law on Investment

Objectives

4. To have knowledge and understanding about law and theory on investment.
5. To have knowledge and understanding and to be able to explain about the law on investment promotion and protection of investment and investors.
6. To have knowledge and understanding and to be able to resolve and analyze problems related to investment.

Course Description

Investment theories, types of investment, domestic investment law and international investment law, roles of capital importing states and capital exporting states for overseas investment, roles of investors and business organization on the economies of capital importing countries and world economies, international law on protection of aliens, investors and investment.

41704 Advanced Labour Law**(6 credits)***Comprises 2 courses of 3 credits each***41704-1 Advanced Labour Law 1: International Labour Standards, Employment Contract, and Labour Protection Law*****Objectives***

1. To acquire knowledge and understanding to be able to explain international labour standards and obligations under international labour standards.
2. To acquire knowledge and understanding to be able to explain various principles of employment contract, termination of employment contract, labour protection law, including occupational safety, health and environment law.
3. To be able to apply the knowledge and understanding of labour laws to resolving various problems that may arise, in comparison with international labour standards. Consequently, to be capable of synthesize a guideline on the improvement or amendment of the mentioned labour laws to be more appropriate and reasonable.

Course Description

International labour standards and obligations regarding international labour standards, employment contract and termination of employment contract, labour protection law and occupational safety, health and environment law.

41704-2 Advanced Labour Law 2: Specific Categories of Labour Protection Laws, Compensation Law, Social Security Law, Labour Relations Law, Labour Court System and Labour Judicial Procedures and Labour Law Enforcement

Objectives

1. To acquire knowledge and understanding to be able to explain various principles of specific categories of labour protection laws: fishing at sea, loading or unloading of goods on and from maritime vessels, land transportation, home work, agricultural work, certain types of work and certain types of employer, including the protection of elderly workers and migrant workers.
2. To acquire knowledge and understanding to be able to explain compensation law and social security law.
3. To acquire knowledge and understanding to be able to explain labour relations law, labour court system and labour judicial procedures.
4. To acquire knowledge and understanding to be able to explain the principles of various labour laws enforcement.
5. To be able to apply the knowledge and understanding of labour laws to resolving various problems that may arise, in comparison with international labour standards, Consequently, to be capable to synthesize a guideline on the improvement or amendment of the mentioned labour laws to be more appropriate and reasonable.

Course Description

Specific categories of labour protection laws, the protection of elderly workers and migrant workers, compensation law and social security law, labour relations law, labour court system and labour judicial procedures and labour law enforcement.

41705 Advanced Taxation Law**(6 credits)*****Objectives***

1. To have knowledge and understanding and to be able to explain about theory and basic concept on taxation law.
2. To have knowledge and understanding and to be able to explain about a relationship between advanced taxation law, finance law and budget law, finance and economy of states.
3. To have knowledge and understanding and to be able to explain about theories on international taxation, regulations on double taxation, procedures of taxation law in Thailand.
4. To have knowledge and understanding and able to explain various tax principles.
5. To have knowledge and understanding and able to diagnose and analyze problems related to tax laws.

Course Description

The theory and basic concepts on advanced taxation law, relationship between advanced taxation law, finance law and budget law, finance and economy of states, theories on international taxation, regulations on double taxation, theory and concept on types of taxation, taxation base, tax rate, taxation and legal protection of private tax payers, structure of taxation system in Thailand, business tax burdens, particularly income taxes, VAT tax and specific business tax, international convention on double taxation, principles on various types of duties comprising of revenue duty, customs duty, excise duty and other important taxes such as property tax, community tax, heritage tax.

41706 Advanced Environmental Law มหาวิทยาลัย**(6 credits)*****Objectives***

1. To have knowledge and understanding and to be able to explain about concepts, theory and criterion of environmental law.
2. To have knowledge and understanding and to be able to analyze environmental problems related to international business, trade, investment.
3. To have knowledge and understanding and to be able to explain about a relationship between various types of environmental problems and environmental problem eradication and rehabilitation mechanism in trade and investment sectors.
4. To have knowledge and understanding and to be able to explain about measures and mechanism in preserving environment under the multidimensional legal, framework, both international level, including international environment agreements, and domestic environmental laws.

Course Description

The concept, theory and criteria of environmental law, environmental problems in connection with business, trade, international investment, the types of environmental problems, air, water, land, and subsoil pollution, environmental problems in community and industry, mechanism for eradication of environmental problem, Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and their disposal, Multilateral Environment Agreements, various types of environmental protection measures, comparative study of environmental protection law and measures both in Thai and foreign legal system.

41707 Advanced Intellectual Property Law

(6 credits)

Comprises 3 courses of 2 credits each

41707-1 Principle of Intellectual Property and Copyright Law

Objectives

1. To have knowledge and understanding and to be able to explain about theories, concept and philosophy as well as the evolution of intellectual property right and copyright protection.
2. To have knowledge and understanding and to be able to explain about theories, concept, philosophy and evolution of international law and organizations related to Copyright right protection.
3. To have resolve and analyze copyright law problems, both foreign and Thai laws.

Course Description

Explains the theory, concept and philosophy as well as the evolution of international organization and international conventions related to protection of copyright and the protection of copyright in Thailand, department of intellectual property, the central intellectual property and international trade court.

41707-2 Advanced Patent Law

Objectives

1. To have knowledge and understanding and to be able to explain about theories, concept and philosophy as well as the evolution of patent protection.
2. To have knowledge and understanding and to be able to explain about theories, concept, philosophy and evolution of international law on patent protection.
3. To have knowledge and understanding and to be able to explain about theories, concept, philosophy and evolution of organizations related to patent protection.
4. To have knowledge and understanding and to be able to explain, resolve and analyze patent law problems, both foreign and Thai laws on patent protection.

Course Description

Explains the theory, concept and philosophy as well as the evolution of international organizations, international conventions related to protection of Patent and the protection of Patent in Thailand, department of intellectual property, the central intellectual property and international trade court.

41707-3 Advanced Trademark Law***Objectives***

1. To have knowledge and understanding and to be able to explain about theories, concept and philosophy as well as the evolution of Trademark, Trade Secret, Geographical Indication, Biodiversity, Genetic Engineering and Digital protection.
2. To have knowledge and understanding and to be able to explain about theories, concept, philosophy and evolution of international law and organizations related to protection.
3. To have resolve and analyze Trademark, Trade Secret, Geographical Indication, Biodiversity, Genetic Engineering and Digital laws problems, both foreign and Thai laws.

Course Description

Explains the theory, concept and philosophy as well as the evolution of protection of international organizations and international conventions related to protection of Trademark, Trade Secret, Geographical Indication, Biodiversity, Genetic Engineering and Digital.

41708 International Commercial Arbitration**(6 credits)*****Objectives***

1. To have knowledge and understanding and to be able to explain about problems relating to the conduct of dispute settlement procedure in courts.
2. To have knowledge and understanding and to be able to explain about alternative dispute resolution.
3. To have knowledge and understanding and to be able to explain about dispute settlement mechanism in the form of arbitration.
4. To have knowledge and understanding and to be able to draft arbitration agreement.
5. To have knowledge and understanding and to be able to choose from various arbitration systems.
6. To have knowledge and understanding and to be able to act in various functions in arbitration proceedings.

Course Description

The concept, methodology and legal principles on settlement of international dispute by way of arbitration, making of arbitration contract, conduct of arbitration proceedings of important arbitration institutions and arbitration conducted under the UNCITRAL Rules, enforcement of arbitral award under New York Convention, arbitration under the regime of International Centre for Settlement of Investment Disputes (ICSID) of World Bank.

41709 Advanced Property and Real Estate Law**(6 credits)*****Objectives***

1. To have knowledge and understanding about the roots of property law.
2. To acquire knowledge and an understanding of the real estate development and real estate business entrepreneurship.

3. To analyze problematic issues and subsequently ascertain proper solutions or make suggestions to amend the current property law and related law areas, especially the real estate development and real estate business entrepreneurship.

Course Description

The root of property law beginning with the legal concepts, property right and acquisition of ownership, exercise of right and its restriction, co-ownership, possessory right, acquisition of ownership in others' immovable property, condominium ownership, related law areas, especially the real estate development and real estate business entrepreneurship.

41710 Advanced Consumer Protection Law and

(6 credits)

Product Liability Law

Objectives

1. To have knowledge and understanding about philosophy, concept and principles related to consumer protection.
2. To have knowledge and understanding and to be able to explain about measures and mechanism and practices about consumer protection and remedies for aggrieved consumers.
3. To have knowledge and understanding and to be able to explain about fundamental right of consumers.
4. To have knowledge and understanding and to be able to explain about laws and institutions on consumer protection in Thailand and different countries.
5. To have knowledge and understanding and to be able to explain about legal measures on consumer protection in term of quality of product and services, price, labeling, packaging, advertisement.
6. To have knowledge and understanding and to be able to analyze and resolve problems relating to laws and measures on consumer protection.
7. To have knowledge and understanding and to be able to explain about the legal principles for product liability, obligations and liabilities of entrepreneurs for consumers.
8. To have knowledge and understanding and to be able to explain about consumer case procedure.
9. To have knowledge and understanding and to be able to explain about consumer case study.

Course Description

The philosophy, concept and principles related to consumer protection, legal measures on consumer protection, mechanism and practices for consumer protection, remedies for aggrieved consumers, and fundamental right of consumers, comparative study on laws and institutions on consumer protection in Thailand and different countries, problems and approaches in amendment of laws, mechanism and measures for consumer protection, legal measures on consumer protection in term of quality of product and services, price, labeling, packing, packaging, advertisement, organizations and institutions for consumer protection pursuant to Consumer Protection Act and other relevant laws as

well as principles, mechanism, measures, legal principles for product liability, obligations and liabilities of entrepreneurs towards consumers and legal measures on damage liability from unsafe products, consumer case procedure act and consumer case study.

41711 Advanced Constitution and Political Institution

(6 credits)

Objectives

1. To have knowledge and understanding and to be able to explain about concept and theory on constitutional law.
2. To have knowledge and understanding and to be able to explain about the concept on limitation of state power.
3. To have knowledge and understanding and to be able to explain about theory and control mechanism of constitutionality of laws.
4. To have knowledge and understanding and to be able to analyze the evolution history of constitutional right and freedom in Thailand's legal system.
5. To have knowledge and understanding and able to explain constitutional and political processes, including the relationship between political institutions in democracy system.
6. To have knowledge and understanding and able to compare the evolution of political and administrative systems, political party systems and election process in democratic countries.

Course Description

The philosophy and concept, theory, various important principles of constitutional, principle of Legal state, principle of democracy, concepts on limitation of state power, principle of separation of powers, principle of rights and freedoms of the individual, principle of supremacy of parliament, concept of the supremacy of the constitution and control of constitutionality of laws and evolution related to this principle, evolution of political and administrative systems and political institutions, both in Thailand and overseas, constitutional and political processes, relationship between political institutions in system together with comparing political party systems and election process in democratic countries.

41712 Advanced Administrative Law

(6 credits)

Objectives

1. To have knowledge and understanding and to be able to explain about and analyze various theories of administrative law.
2. To have knowledge and understanding and to be able to explain about and analyze administrative contract.
3. To have knowledge and understanding and to be able to explain about and analyze administrative liability.
4. To have knowledge and understanding and to be able to explain about and analyze a control of administrative action.

5. To have knowledge and understanding and to be able to explain about and analyze administrative law problems.

Course Description

Study the root of administrative law, various theories of administrative law, administrative contract, structure of administration, management of public officers, administrative liability, property of public bodies, control of administrative action by studying the Thai and foreign systems.

41713 International Organizations Law

(6 credits)

Objectives

1. To have knowledge and understanding and to be able to explain about fundamental concept on international organization law.
2. To have knowledge and understanding and to be able to analyze various international organization case studies.

Course Description

Basic concepts on international organization law, various criteria, structure and internal management, analysis of case study of international organization such as United Nations, international organization at regional level and International Court of Justice.

41714 Advanced Public Finance and Budgeting Law

(6 credits)

Objectives

1. To have knowledge and understanding and to be able to explain about theory on public finance and budget.
2. To have knowledge and understanding and to be able to explain about structure of public revenue and expenditure.
3. To have knowledge and understanding and to be able to explain about concept on control of public finance.
4. To have knowledge and understanding and to be able to explain about concept on local public finance.

Course Description

The Concept, theory, policy finance, budget, taxation, public revenue and expenditure structure and concepts about parliament and governmental control of public finance, finance institutions and public finance and other organizations.

41715 Advanced Local Administration Law

(6 credits)

Objectives

1. To have knowledge and understanding and to be able to explain about principle on distribution of administrative power.
2. To have knowledge and understanding and to be able to explain about establishment of local administration.
3. To have knowledge and understanding and to be able to explain about the establishment of structure and authority of local administration.

5. To have knowledge and understanding and to be able to explain about control of legality of administrative actions.

Course Description

Distribution of administrative power principle, concept on local administration, structure and powers of local administration, carrying on administrative activities and making of administrative contracts by local administration, legality of administrative actions, liability for performance of duties of officers and members of local administration council, local finance.

41716-1 Advanced Criminal Laws

3. To have knowledge and understanding and to be able to explain about theories on criminal liability and punishment.

Course Description

History and evolution of criminal laws and criminology, offence and penalty, causes of offences, theories on criminal liability and punishment, reform of criminal law and important issues on criminology.

Course Description

Theory and principle on general management and criminal justice administration, comparative study of justice systems of various countries, criminal justice procedures.

41719 Criminal Justice Laws Concerning the Control and Suppression of Major Domestic and Transnational Crimes (6 credits)

Objectives

1. To have knowledge and understanding and to be able to explain about evolution on criminal justice law concerning the control and suppression of political crimes.
2. To have knowledge and understanding and to be able to explain about international cooperation for the control of various crimes as mentioned in (1).

Course Description

Evolution of criminal justice law concerning the control and suppression of major domestic and transnational crimes, international cooperation for the control and suppression of various crimes including extradition.

41797 Independent Study (6 credits)

Objectives

1. To have knowledge and understanding and to be able to explain about the knowledge and understanding and to conduct a study or legal research on a topic of interest.
2. To have knowledge and understanding and to be able to conduct independent study on a topic of interest at master's degree level and compose an academic report.

Course Description

Structure and patterns of independent research, selection of topic for independent research on business law, administrative law, criminal law and justice procedure, writing up and proposal of research study, systematic learning of specific topic, collection and analysis of research study and presentation of independent study.

41798 Thesis (12 credit)

Objectives

1. To be able to select research problems for a thesis.
2. To be able to survey and analyze literature related to the thesis.
3. To be able to design research for the thesis.
4. To gain knowledge and skill in writing and presenting the thesis proposal.
5. To be able to develop quantitative research tools.
6. To be able to develop qualitative research tools.
7. To be able to collect, analyze, and present data for the thesis.
8. To be able to present and defend the thesis examination.
9. To be able to write the complete thesis report.
10. To be able to write the research report for publication.

Course Description

Selection of the research problem; survey and analysis of relevant literature; research design; writing and presenting a thesis proposal; tool development for thesis research, both quantitative and qualitative research; data collection; thesis data presentation; thesis presentation and examination defending; writing the complete thesis report; writing the research report for publication.
