### Doctor' Degree

#### 41901 Advanced Research Methodology in Laws

(6 credits)

##### *Course Learning Outcomes*

1. To gain knowledge and understanding about research methodology in laws, the importance of research, important guidelines used in analysis, research design and random sampling for research purposes and data analysis for research purposes.
2. To gain knowledge and understanding about the concept of legal research including the research process in laws and to be able to implement such processes.
3. To enhance problem analysis skill, research writing, presentation and dissemination of legal research.

##### *Course Description*

This course includes research methodology in laws, definition and importance of research, quantitative and qualitative research, researchers' ethics, research topic analysis, data collection and data analysis for research purposes, questionnaire design, analysis, and random sampling for research purposes, including data analysis for research purposes, both quantitative and qualitative research, research writing, research article writing, presentation, and dissemination of legal research.

#### 41902 English for Legal Research

(6 credits)

##### *Advanced Comparative Law*

##### *Course Learning Outcomes*

1. Use English in conducting legal research whereby students shall be able to read legal research in English.
2. Understand English reading and writing process including the writing structure of legal research.
3. Apply the knowledge from legal research in content writing and citations for research at the level of Doctor of Laws.
4. Write abstract, article, and summary of a research.
5. Search for English information sources for legal research.

##### *Course Description*

This course covers the use of English for legal research, types of legal research in other countries, process and technique of English reading, the use of English vocabulary and grammar, English writing process, translation and summarization of English legal research, writing structure of English legal research, and access to various information sources for research writing and citation formats in legal research.

**41903 Advanced Research Seminar on Legal Problem Analysis****(6 credits)*****Course Learning Outcomes***

1. To train students to gain understanding and possess analytical thinking skills, and being able to synthesize legal problems in the important fields of laws. Students should also understand the interaction between laws, society, economy, politics, and environment.
2. To train students to ensure that they will have the ability to solve legal problems through study and information research, and for them to be able to utilize the legal research process to solve legal problems.
3. To train students to gain the ability to apply legal principles in different contexts, to ensure that students understand the legal mechanisms and law enforcement, including the development of legislative process and integrated legislative system as well as the creation of enlightened society through legal analysis and synthesis.

***Course Description***

This course covers analysis and synthesis of advanced legal issues and problems in the important fields of laws including civil and commercial laws, laws on trade, economics, investment, labour, social security and industry, criminal law and justice system, public law, international law, and others. This course also focuses analysis and synthesis of problem characteristics and correlation between legal problems and society. Students will be required to analyze and synthesize the cause of problems, legal theories, legal issues, the dynamics of law and changes in society, development of law, proposition of process and solutions to amend law and state laws and policies.

**41997 Dissertation****(6 credits)*****Course Learning Outcomes*** The students should be able to

1. Create concept and research structure for a doctoral dissertation.
2. Explore concepts, theories, meanings, and evolution of related laws.
3. Explore international law and related foreign law.
4. Analyze law in Thailand comparatively with international law and/or foreign law
5. Design and develop tools to collect research data for doctoral dissertation
6. Design and proceed with data collection and analyze research for dissertation at Doctor of Laws level
7. Apply the analysis results as a guideline for amending, adjusting, and adding the law that is thematic to the research problem
8. Develop law to address social, economic, political, and cultural problems
9. Write a research report and disseminate a doctoral dissertation

### ***Course Description***

In this course, students are required to identify issues related to law, society, economy, politics, and culture and plan a research study, review, and analyze relevant literature to define the research conceptual framework for the dissertation. Students will prepare doctoral dissertation outline, research design, sample assignment, variable measurement plan, and research tools development. Students will design data analysis method, prepare report, concept and research project for doctoral dissertation. The students will be required to create research tool, conduct tool quality assurance and data collection, data analysis, present data analysis outcome, summary, discuss about outcome and recommendation, present final research for publication, conduct research writing and presentation of the complete research and the publication of such doctoral dissertation.

### **41999 Doctoral Professional Experience in Laws**

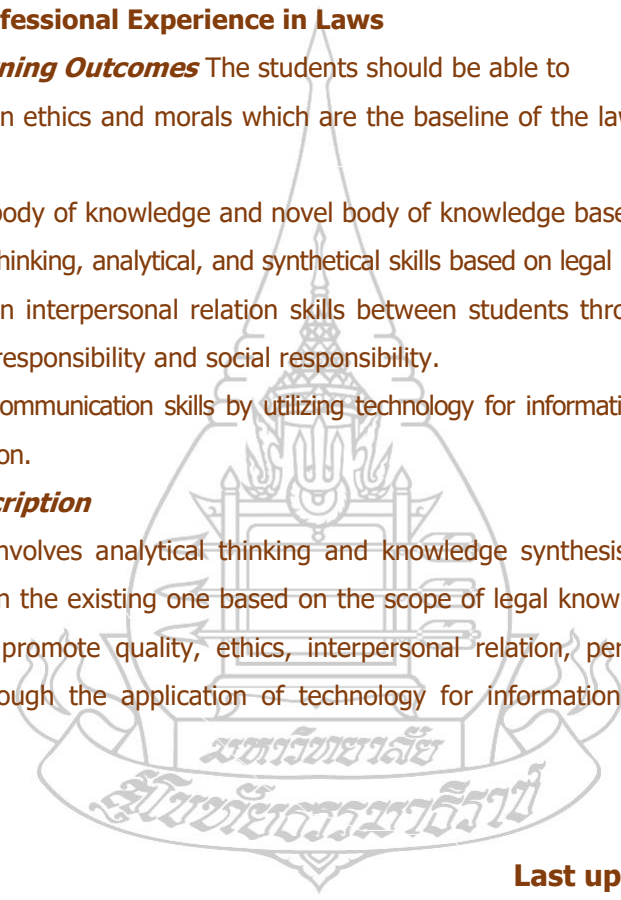
**(6 credits)**

***Course Learning Outcomes*** The students should be able to

1. Strengthen ethics and morals which are the baseline of the law, economy, politics, and Culture.
2. Develop body of knowledge and novel body of knowledge based on legal foundation.
3. Improve thinking, analytical, and synthetical skills based on legal knowledge foundation.
4. Strengthen interpersonal relation skills between students through group activities and personal responsibility and social responsibility.
5. Improve communication skills by utilizing technology for information searching and research presentation.
