# 10121 Human Civilization

(6 credits)

# **Objectives**

- 1. To have knowledge on Eastern and Western civilization in terms of politics, economy, and society.
- 2. To understand human civilization in the past which is fundamental of the current civilization.
- 3. To realize and appreciate the values of human civilization.

# Course Description

Knowledge on Eastern and Western civilization human has created in terms of politics, economy, society, wisdom, arts, as well as science and technology.

#### 10131 Human Society

(6 credits)

# **Objectives**

#### **Course Description**

# 10141 Science, Technology and Environment for Life

(6 credits)

# **Objectives**

- 1. To gain knowledge about the concepts, rules and development of science and technology, and how they influence of thought and human livelihood.
- 2. To gain knowledge about the evolution of living things and human beings.
- 3. To understand the relationship between humans, the environment, and the effects of science and technology on the environment.
- 4. To gain knowledge of the applications of science, technology, and mathematics in daily life.
- 5. To enhance scientific thinking and awareness of the need for environmental preservation.

#### **Course Description**

Concepts, theories, critical thinking, rules and development of science and technology; natural history concerning human beings; the parts of the human body; humans and the environment; hygiene and nutrition; the application of science, technology, and mathematics in everyday life.

10151 Thai Studies (6 credits)

#### **Objectives**

- 1. To learn about Thailand's history, society, language and culture.
- 2. To be able to apply the course knowledge to daily life.
- 3. To understand and take pride in what it means to be Thai.

### Course Description

Knowledge about Thai in terms of history, settlement, politics, economy, culture, religion and ritual, language and literature, arts and culture.

#### 10152 Thailand and the World Community

(6 credits)

# **Objectives**

- 1. To be able to gain knowledge on situations, trends and characteristics of economic, social and political relations and changes in the world community which affect Thailand.
- 2. To gain knowledge on the status of Thailand in the world community.
- 3. To be able to analyze the problem as a result of globalization in various aspects including political, economical, social and culture and impact on moral and ethic.

#### Course Description

Status of Thailand in social world; dynamic of social changes which affecting Thailand; problems and causes of problems arising as a result of globalization which cause the awareness, knowledge and understanding of the situation; be able to analyze the cause of problem and the impact of Thai society in various aspect including political, economic, social, moral and ethical.

Significance of language, idea and communication; the art of using word, sentence, idiom, phrase; development of listening, speaking, reading and writing skills to communicate effectively and creatively; using Thai language in daily life to pursuit of knowledge and transfer knowledge.

#### 10162 Chinese for Communication

(6 credits)

#### **Objectives**

- 1. To gain knowledge about Standard Chinese phonology, Mandarin phonetic alphabet (Hanyu Pinyin), and be able to write and pronounce the alphabet correctly.
- 2. To gain knowledge about Chinese characters--as basic words or assembled ones--and sentence structure and grammar for general communication, including practice with writing Chinese characters.
- 3. To be able to use Chinese in everyday life.

# **Course Description**

Standard Chinese phonology, Hanyu Pinyin transcription, basic words, and dialogues for everyday use, structural grammar, and learn and practice writing of 550 Chinese characters.

#### 10163 Khmer for Communication

(6 credits)

# **Objectives**

- 1. To possess knowledge on the phonology, letters, grammatical structure and basis sentence structure of Khmer
- 2. To be able to use basic Khmer for communication in daily life.
- 3. To possess knowledge on Khmer words used in the Thai language.

#### **Course Description**

Khmer phonology; the practice of writing the Khmer alphabet; Crieng and Mul alphabets, basic Khmer words used in daily life; grammatical structure and basic sentence structure; listening, speaking, reading and writing skills for communication at the basic level; and Khmer words used in Thai language.

#### **40101** General Principles of Law

(6 credits)

#### **Objectives**

- 1. Students acquire the basic knowledge about general principles of law.
- 2. Students develop the understanding about the relation between laws and society.
- 3. Students acquire the knowledge about important laws and laws relating to daily life.
- 4. Students understand the role of law users in various institutions in society and emphasize the ethics of the legal profession.

# Course Description

Meaning, nature and structure of law in general; origin and evolution of law; theories and concepts of law; different legal systems; sources of law; hierarchy of law; application and interpretation of law; content of various laws; some important legal principles; relationships among different types of law; relationship between law and other related disciplines; law in daily life and legal practice including ethics of the legal profession.

#### **41001** The Law for Community Leaders

(6 credits)

- 1. To acquire the knowledge and understanding about the subject-matter of the laws necessary for community leaders, in relation to the introduction to law, civil and commercial laws, criminal laws, public law and other laws which are essential to community leaders.
- 2. Students can use the knowledge about those laws for the problem-solving in order to give advice to members of the community.

Study of provisions in various laws which mention the concepts and subject-matter of the criteria, by commencing to study civil and commercial law, criminal law, drugs law, labour law, the Constitution, and constitutional laws, election law, fundamental principles of administrative laws, organization of administrative agencies and people's rights and protection of people in justice system.

# 41002 Economics, Politics and Governments for Community Leaders (6 credits) Objectives

- 1. To acquire the knowledge about fundamental economic questions and operating process of various economic systems.
- 2. To acquire the knowledge about the concepts of market mechanism and stability in economic system.
- 3. To acquire the knowledge about the concepts of Thailand's national economic and social development plan.
- 4. To acquire the knowledge about the concept, evolution and approach on political and administrative system.
- 5. To acquire the knowledge about the concept and the study of the influence of economic systems affecting political change.
- 6. To acquire the knowledge about the evolution, scope and political and administrative situation in Thailand.

#### **Course Description**

Meaning and fundamental economic questions, economic system, mechanism and concept, microeconomic and macroeconomic theories in terms of consumption, savings, production and investment of private and governmental sectors, balance and relation of various types of market in open economy system and closed economy system and national economic and social development planning, study and analysis of important issues related to state, political institution, political groups, public policies and political system, network evolution, status, and study approach to the impact of economic system on political change, network evolution and political status and administration in Thailand.

# 41003 Community Management

(6 credits)

#### **Objectives**

- 1. To explain the concepts and principles about the community and community development.
- 2. To explain the concepts, theories and principles on community management.
- 3. To apply the concepts, theories and principles on community development and community management in practice.

#### **Course Description**

Concepts, theories, principles about community, community development, process and techniques of efficient and effective community management by promoting the participation and network of cooperation between people in community, creation of knowledge-based, integrated, quality, honest, community-centered community, as well as creation of traditional knowledge to balanced development and sustainable comparative advantage.

# 41004 Professional Experience in Community Leaders

(6 credits)

#### **Objectives**

- 1. Students acquire the leadership and develop the personality for leadership.
- 2. Students acquire the necessary knowledge for self-development as well as administration of human resources and work.
- 3. Students master their skills in leadership, group activity and community network building.

#### **Course Description**

Enhancement of leadership and personality for leaders, potential in thinking, effective community, public speaking skills, leader speaking, public psychology, use of information technology for leader, skill in conducting a meeting, project write-up and presentation, problem-solving and decision-making, conflict management, improvement of inter personal skill and emotional maturity, creation of service mindset, as well as morality, ethics and public conscience for community leaders.

# 41005 Protection of Rights and Liberties of the People

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge and understanding about the key elements of basic rights and freedom which deserve to be protected and guaranteed.
- 2. Students can understand the laws relevant to the protection of rights and freedom.

### **Course Description**

Study concepts of rights and freedom of people and various relevant laws by commencing the study on concepts and principles on rights and freedom, protection of rights and liberties of the people, protection of rights and liberties organization, protection of rights and liberties depending on the types of rights and liberties.

# 41006 Administration of Local Administration Organizations

(6 credits)

# **Objectives**

- 1. To study theories about the relation between state and local community both at national and international level.
- 2. To study the pattern and administration procedures of local administration organizations.
- 3. To study the case studies and problem-solving approaches of local administration organizations both in Thailand and overseas.

#### Course Description

Relation between state and local community, concept of civil society, types of administration which emphasize the participation and distribution of power, concepts of management of local administration organizations (covering dimensions in political science, law, management and political communication), history of administration and culture, Thai.

# **41007** Development of Community Products

(6 credits)

- 1. To study the origin and importance, types and patterns of community products.
- 2. To acquire the knowledge and understanding about various community products and tourist attractions including cultural and customs tourist attractions.

### 41008 Management of Agriculture, Natural Resources, and Environment

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge about management in agriculture, natural resources and sustainable environment.
- 2. Students acquire basic knowledge about agricultural management.
- 3. Students acquire basic knowledge about forestry management.
- 4. Students can integrate knowledge about agricultural management, natural resources and sustainable development.

#### **Course Description**

Concepts of management in agriculture, natural resources and sustainable environment, basic knowledge in agricultural management such as management in plant and animal production, management in processing of agricultural product, management in marketing of agricultural product, alternative agriculture management, sustainable forestry management, basic knowledge in forestry management such as forestry, forest park, community forest and eco-tourism, community environment and environmental pollution, basic knowledge in community waste water management, community rubbish and waste, as well as sustainable community development.

41201 Public Law (6 credits)

# **Objectives**

- 1. Students acquire the knowledge and understanding about general principles of public law.
- 2. Students acquire the knowledge and understanding about various branches of public law, especially constitutional law, administrative law and organic laws.

# Course Description

Definition and principles of public law with emphasis on constitutional law including concepts of the state, governmental systems, heads of state, divisions of power, use of sovereignty, and policies of the state; civil rights and civil liberties compared with the Universal Declaration of Human Rights; judicial review and amendment of the constitution.

Constitutional law; organic law; political party law; administrative law including state administration; the theories of centralization and decentralization of power; division of administrative responsibility; public services; relationship between public officials and the state; control of public official discretion and concepts of administrative courts.

#### 41211 Civil Law I: Persons, Juristic Acts and Contracts

(6 credits)

- 1. Students acquire the knowledge and understanding about basic principles of civil law related to persons, juristic acts and contract.
- 2. Students can apply the acquired knowledge to solve problems or facts.
- 3. Students understand the principles and rationale of each law and emphasises the relevancy of the law to the society.

The law of persons: commencement and dissolution of a person, capacity, domicile and juristic person.

The law of juristic acts: definition, characteristics and form of juristic acts; display of intention; validity of juristic acts; conditions and time of juristic acts; periods of time and prescription.

The law of contracts: formation of contracts, effect of contracts, recession of contracts, earnest and stipulated penalties.

# 41212 Civil Law II: Obligations and Delicts

(6 credits)

#### **Objectives**

- 1. Students can acquire the knowledge and understanding about the principles of law of obligations, tort, the law of management of affairs without mandate and the law of undue enrichment.
- 2. Students can apply the acquired knowledge to solve problems or facts.
- 3. Students understand the principles and rationale of each law and emphasises the relevancy of the law to the society.

#### **Course Description**

The law of obligations: definition and object of obligations; subrogation; transfer of claims; exercising debtor's rights; revocation; fraud; right of retention; preferential rights; plurality of debtors and creditors; extinction of obligations.

The law of tort: Liability for one's own or other's wrongful acts; liability as the owner of property which is the basis of tort; compensation for tort; limitations; justifiable acts.

The law of management of affairs without mandate and the law of undue enrichment.

#### 41213 Property Law

(6 credits)

# **Objectives**

- 1. Students acquire the knowledge and understanding about the property law, land law, land reform law and laws relating to other types of properties.
- 2. Students apply the acquired knowledge to solve problems or facts.
- 3. Students understand the principles and rationale of each law and emphasises the relevancy of the law to the society.

#### Course Description

The law of property: definition and categories of property; registration of property; exercise and restriction of the owner's rights; acquisition of immovable property or other real rights including ownership in a condominium.

Land law: land allocation; land reform; rights pertaining to land; issuance of documents of title; registration of rights and juristic acts; and stipulation of rights pertaining to land in some circumstances.

#### 41231 Criminal Law I: General Principles

(6 credits)

- 2. Students can acquire the knowledge and understanding about provisions in Part 1 of the Penal Code and apply the acquired knowledge to solve problems or facts.
- 3. Students acquire basic knowledge about criminology and penology so as to analyze the problems of crime in society.

Characteristics of criminal law; theory of criminal liability; jurisdiction; attempts; principals and supporters; concurrence of offenses; recidivism; prescription; criminal punishment and provisions applicable to petty offenses; theories of criminology and penology.

#### 41232 Criminal Law II: Offenses

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge and understanding about criminal offences under the Penal Code.
- 2. Students can separate elements of various criminal offences under the Penal Code.
- 3. Students can explain and provide examples of criminal offences under the Penal Code.
- 4. Students can analyze the supposed and actual facts.
- 5. Students can compare similar criminal offences.

# **Course Description**

Types of criminal offenses provided in Part 2 and Part 3 of the Penal Code, relating to the security of the kingdom, the government, justice, religion, public peace, public security, counterfeit and alteration, and trade, as well as sexual offenses, and offenses against life, liberty, reputation, property, and petty offenses; the comparison between criminal offenses and other similar wrongdoing actions.

# 41311 Civil Law III: Family Law and Law of Succession

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge and understanding about family and succession.
- 2. Students can apply the acquired knowledge to solve problems or facts and implement them.
- 3. Students acquire basic knowledge about criminology and penology so as to analyze the problems of crime in society.

# **Course Description**

Family law: betrothal, marriage, relationship of husband and wife, property of husband and wife, validity of marriage, dissolution of marriage, rights and duties of parent and child, guardianship, adoption, and maintenance.

Law of succession: devolution of an estate, heirship, statutory rights of inheritance, division into portions among the several classes and degree of statutory heirs, representation for the purpose of receiving inheritances, legatees, forms of wills, effects and interpretation of wills, validity of wills, clauses in wills, administration and distribution of an estate, vacant estates, prescription for law of succession.

# 41321 Commercial Law I: Sales, Hire and Hire-purchase

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge and understanding about principles of commercial law in Book 3, specific contract, sales contract, exchange, hire, hire-purchase, hire of labour, hire of work, carriage contracts and laws relating to the criteria of the said law.
- 2. Students can apply the acquired knowledge to solve problems or facts and implement them.

#### **Course Description**

Law of sales: characteristics, types and systems of sales contracts, duties and liabilities of the contracting parties, consumer protection, specific types of sales and guidelines of practice in business transactions, law of hire, characteristics and forms of hire, rights and liabilities of contracting parties, extinction of contracts of hire, law of hire-purchase, employment, and carriage, and introduction to law on e-commerce.

# 41322 Commercial Law II: Loans, Deposits, Agents and Insurance (6 credits) Objectives

- 1. Students acquire the knowledge and understanding about the legal principles about loans, deposit, warehousing.
- 2. Students can apply the acquired knowledge to solve problems or facts and implement them.
- 3. Students understand the principles and rationale of each law and emphasises the relevancy of the law to the society.

# **Course Description**

Law of loans: loan for use, loan for consumption, deposit, warehousing.

Law of agencies: characteristics and types of agents, agents and principals' duties and liabilities to each other and to third persons, extinction of agency, agency commissions.

Law of brokerage: law of compromise and settlement, laws relating to gambling and betting.

Law of insurance: insurance against loss, insurance on carriage, guarantee insurance, life insurance.

# 41323 Commercial Law III: Suretyships, Mortgages and Bills Objectives (6 credits)

- 1. Students acquire the knowledge and understanding about guarantee, suretyships, mortgage, and pledge, current accounts, bill of exchange, and other relevant laws, including trade practices.
- 2. Students can apply the acquired knowledge to solve problems or facts and implement them.
- 3. Students understand the principles and rationale of each law and emphasises the relevancy of the law to the society.

#### **Course Description**

Laws relating to guarantee, suretyships, mortgage, and pledge.

Laws relating to current accounts and bills, bills of exchange, promissory notes and cheques; criminal offenses related to the use of cheques, and commercial business related to bills.

# 41324 Commercial Law IV: Partnerships and Companies (6 credits) Objectives

- 1. In order for students to understand the principles of stable law, companies including companies.
- 2. To allow students to know how to manage the partnership, company, purpose, purpose of setting up a company separation, merger, capital increase, capital reduction, funding for business organizations in the capital market, accounting, financial statements, auditing and the development of contemporary business organizations.

#### **Course Description**

Law on the partnership of the company Study from concept Business model from past to present Study the partnership and the company since the ordinary partnership Limited Partnership and Limited Company Which emphasizes the condition and establishment of a partnership shareholders, general characteristics of ordinary partnerships, operations, changes, domination, management and dissolution of an ordinary partnership limited partnership And limited company Public company Funding for business organizations in the capital market, accounting, financial statements, auditing And the development of contemporary business organizations.

# 41341 Procedural Law I: General Principles in Civil Procedure

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge and understanding about the Thai court system including powers of judges.
- 2. Students acquire the knowledge and understanding about the general principles on civil court procedures and general principles on law of evidence.
- 3. Students can apply the acquired knowledge to solve problems or facts and implement them.

# **Course Description**

Law for the Organization of Courts of Justice; system of the Courts of Justice; levels of the courts; establishment or dissolution of the courts; judges at each level of the courts; power of judges at different levels; jurisdiction and competency of courts; the judgment party and competency of a single judge.

Civil Procedure Code Division I: jurisdiction and competency of courts in civil cases; challenge of judges; powers and duties of courts; hearings; memorandums and filing; parties; filing and service of pleadings and documents; judgments and orders; court costs.

General rules concerning law of evidence; general evidence; attendance and examination of witnesses; production of documentary evidence; inspection by court and appointment of experts by court.

# 41342 Procedural Law II: Civil Procedure and Bankruptcy Law

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge and understanding about civil procedure at court of first instance as well as Supreme Court (Dika Court) and execution of civil case.
- 2. Students acquire the knowledge and understanding about the bankruptcy law.
- 3. Students can apply the acquired knowledge to solve problems or facts and implement them.

# Course Description

Civil Procedure Code continued from Procedural Law I: ordinary and special procedures in Courts of First Instance including procedures for petty cases, procedures in case of default and arbitration, procedures in appeals court and supreme court; provisional measures before judgment; execution of judgments and orders.

Law of bankruptcy: filing of bankruptcy suits, attachment and seizure of property, adjudication of bankruptcy and discharge from bankruptcy.

# 41343 Procedural Law III: Criminal Procedure

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge and understanding about criminal procedures at first instance court, appeal court, Supreme Court (Dika Court) and legal execution procedure.
- 2. Students acquire the knowledge and understanding about evidences in criminal case, investigation, interrogation and forensic medicine.
- 3. Students can apply the acquired knowledge to solve problems or facts and implement them.

#### **Course Description**

Criminal procedure Code: powers of inquiry officials and competency of courts; prosecution of criminal cases and filing of civil cases in connection with criminal offenses; summons and criminal warrants; arrest and detention; imprisonment; search and provisional release; interrogation; prosecution of criminal cases; preliminary examination; hearing judgments and orders in the appeals and supreme courts; execution of judgments and fees; pardons; commutation and reduction of punishment.

Evidence in criminal cases; witnesses; material and documentary evidence; experts; investigation, interrogation and forensic medicine.

Criminal procedure in district courts, juvenile and family courts.

# 41401 English for Lawyers

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge and understanding about vocabularies and legal English idioms.
- 2. Students can read and understand articles or legal texts in English.

# **Course Description**

General English legal vocabulary and terminology for the purpose of reading and comprehending legal texts written in English.

# 41402 Thai and Foreign Legal Systems

(6 credits)

# **Objectives**

- 1. Students acquire the knowledge and understanding about major foreign legal systems which influence world legal systems and Thai laws as a basis of understanding for the research studies of foreign laws and comparative legal studies.
- 2. Students acquire the knowledge and understanding about the history and evolution of the Thai legal system.

# **Course Description**

Historical evolution of important legal principles; judicial systems; the influence of major foreign legal systems.

Historical evolution of the Thai legal and judicial systems from the Sukhothai period to the present time with an emphasis on legal reform and the administration of justice during the reign of King Rama V, and the codification of laws in subsequent periods.

#### 41404 Labor Law

(6 credits)

# **Objectives**

- 1. To acquire the knowledge and understanding about principles and basic concepts and evolution of labour and social security laws.
- 2. To acquire the knowledge and understanding about various principles of labour protection laws and labour relations laws.
- 3. To be able to apply the acquired knowledge to solve problems or facts and implement them.

#### **Course Description**

Background and general theories of labor law and social security law; the Thai Labor Protection Law and its provisions concerning the fundamental rights and duties of employers and employees; the Labor Relations Law and its provisions concerning the relationship between employers and employees; establishment of employers' and employees' organizations in the forms of employers' associations or labor unions; workers' compensation law; social security law and law on labor relations in state enterprises, as well as procedures for the settlement of labor disputes by administrative agencies and the Labor Court.

#### 41405 Environmental Law

(6 credits)

#### **Objectives**

- 1. Students acquire the knowledge and understanding about the environment towards the society.
- 2. Students learn about the general principles of constitutional law on the environment, environment law and legal environment.
- 3. Students study the environmental law relating to the pollution control, the conservation of environment, the preservation of ancient monuments, ancient objects and nature as well as refrain from any acts which emit pollution and hazardous waste and compensation in environment-related lawsuit.
- 4. Students understand the requirement for the report on the analysis of environmental impact and the energy-related laws.

# **Course Description**

The environmental crisis and its effects on global ecology; laws concerning environmental protection and conservation including pollution control and conservation of the environment and nature with emphasis on existing laws, government policies protecting citizens, rights to live in a suitable environment, and standards concerning claims for damages in environmental cases.

Law concerning the control of land utilization and city planning laws.

# 41421 Taxation Law I: Income Tax

(6 credits)

### **Objectives**

- 1. Students acquire the knowledge and understanding about theories of taxation, the relation between taxation and the government's economic pursuit.
- 2. Students acquire the knowledge and understanding about the current tax laws.

# **Course Description**

Theories of taxation; the role of taxation within the economic system; formulating taxation policies to solve economic problems or for economic development; personal and corporate income tax in Thailand; double taxation treaties between Thailand other countries.

#### 41423 International Transaction Law

(6 credits)

# Objectives:

- 1. Students acquire the knowledge and understanding about the introduction to the principles of international trade.
- 2. Students acquire the knowledge and understanding about practices of international trade.
- 3. Students can apply the acquired knowledge to do business.
- 4. Students can solve the legal problems on international trade.

#### **Course Description**

Sources of international transaction law, basic criteria for application of import and export of goods in Thailand, policy and regulation on control of import and export of goods in Thailand and international groups such as ASEAN countries, common European market, East European group, currency control, appointment of foreign commercial agency, monopoly and control, restriction of trading.

Criteria of agreement and liability of contracting parties in international sale contract such as CIF, C&F, FOB contracts, grant of commercial credit and payment of goods, carriage of goods, marine insurance, applicable law in international commercial contract and international commercial dispute settlement mechanism.

#### 41431 Criminal Justice Administration

(6 credits)

#### **Objectives**

- 1. Students understand the duties of agencies in the justice process.
- 2. To provide students with the foundational knowledge about the justice process work, as the integrated administration system.
- 3. To enhance the concepts of the principle of coordination and campaign on the crime in the agencies, justice system and the society as a whole.
- 4. To make students and interested persons realize the role and importance of agencies in the justice system process which affect the well-being of the people and national stability.

# Course Description

Administration of the entire criminal justice system comprising the police, lawyers, prosecutors, courts, prisons, probation and parole; coordination of work and the role of the public in the criminal justice system; concordance between administration of the judicial system and social changes.

# 41432 Criminal Law III: Special Law Offenses

(6 credits)

#### **Objectives**

- 1. Students learn about offenses under special laws.
- 2. Students understand the details of the components of offenses under various acts.
- 3. Students can apply the acquired knowledge to everyday life and their work.
- 4. Graduates acknowledge and realize their duties.

#### **Course Description**

Offenses in relation to state revenue, good public morals, the environment and conservation of nature, public health, narcotic drugs, transportation, commerce and credit stability of the state, city cleanliness, consumer protection, and fair labor practices.

# 41444 Professional Experience in Law

(6 credits)

# **Objectives**

- 1. Students acquire the knowledge and understanding about the status and practice of legal profession.
- 2. Students have the skills to provide legal advice and guidelines on drafting and reviewing of contracts, wills drawing-up, payment of taxes and other aspects of legal work.
- 3. Students have the competence in the conduct of legal proceedings.
- 4. Students understand and realize the code of conduct of legal profession.

#### **Course Description**

Status and practice of the legal profession; law office management; providing legal consultation; drafting and reviewing contracts; preparing wills; payment of taxes; drafting complaints and statements of defense; preparation of litigation; examining witnesses; submission and admission of evidence; drafting judgments; drafting appeals and statement of defense to appeal; requesting provisional measures prior to judgment; execution of judgments and orders; legal ethics; group activities for the development of virtue, ethics and effective leadership qualities.

#### 41451 International Law

(6 credits)

# **Objectives**

- 1. Students acquire the basic knowledge about the theories and principles of international laws as well as the enforcement of international laws.
- 2. Students acquire the knowledge and understanding about the conflict of law, nationality law and extradition.
- 3. Students can apply the acquired knowledge to solve the actual problems or facts and implement them

#### **Course Description**

Characteristics and sources of international laws; relationship between international and national laws; subjects of international law; rights and duties of states; border and territorial sovereignty of states; treaties; settlement of international disputes; war and neutrality.

Characteristics of personal nationality; acquisition and termination of Thai nationality; conflicts of law. International co-operation in crime suppression and extradition.

#### 41452 International Institutes

(6 credits)

# **Objectives**

- 1. Students acquire the knowledge and understanding about the country and powers and authorities of various international institutions.
- 2. Students understand the role of current international organizations.

# **Course Description**

Operational aspects and power of different international organizations such as UN organizations, governmental and non-governmental organizations including international charitable organizations such as the Red Cross.

# 41454 Human Rights Law

(6 credits)

# **Objectives**

- 1. To acquire the knowledge and understanding about the concepts, evolution and legal principles on universal human rights and human rights laws in Thailand.
- 2. To acquire the knowledge and understanding about the mechanism of human right protection at international and national level.
- 3. To apply the knowledge and understanding about human rights law at international and national level to solve the actual problems.

#### Course Description

Concepts and development of human rights, nature of international human rights; promotion and protection of human rights by the United Nations, regional international organizations and non-governmental organizations; mechanisms for protection of human rights in Thailand; rights and liberties of individuals such as liberty of the person, right to fair justice, freedom of conscience and right to privacy, as well as political, economic and cultural rights; rights of a person whose rights are at risk of infringement; civil rights; law, humanity and rights regarding refugees; trends in human rights.

# 41455 Intellectual Property Law

(6 credits)

#### **Objectives**

- 1. To acquire the knowledge and understanding about the concepts and evolution of intellectual property protection and international laws on the protection of intellectual property.
- 2. To acquire the knowledge and understanding about categories of rights, protection and breaches of various intellectual properties protected under the Thai laws or which require further implementation legislation pursuant to the obligations of World Trade Organization.
- 3. To acquire the knowledge and understanding about the Intellectual Property Court and international trade and enforcement of intellectual property.
- 4. To apply the acquired knowledge and understanding about the three objectives to solve the problems concerning intellectual property rights.

# **Course Description**

Historical evolution and important principles of law on copyrights, trademarks, patents, trade secrets, and unfair competition; international agreements on protection of intellectual property; protection of plant varieties; protection of integrated circuits; court procedures on intellectual property cases.

# 41456 Consumer Protection Law and Competition Law

(6 credits)

#### **Objectives**

- 1. To acquire the knowledge and understanding on the concepts and principles on consumer protection.
- 2. To acquire the knowledge and understanding and to be able to explain the measures and mechanism and regulations on consumer protection and remedy of aggrieved consumers.
- 3. To acquire the knowledge and understanding and to be able to explain about the trade competition laws.
- 4. To acquire the knowledge and understanding and to resolve problems relating to the laws and protective measures for trade competition.

# Course Description

Consumer Protection Law and Competition Law seeks to protect the quality of goods and services, price, labeling, packaging, parcel, advertising, organization and institution which are in charge of consumer protection pursuant to Consumer Protection Act and other relevant laws as well as principles, mechanism, measures, legal principles related to commercial competition by preventing business merging or cartel or limit competition, market abuse which may constitute a monopoly or unfair competition.

#### 41457 Taxation Law II: Indirect Tax and Property Tax

(6 credits)

#### **Objectives**

- 1. To acquire the knowledge and understanding on the concepts, meaning, source, objectives of indirect tax and property tax.
- 2. To acquire the knowledge and understanding on the objectives and policy of indirect tax and property tax collection.
- 3. To acquire basic knowledge and understanding on the legal principles and methods of indirect tax and property tax collection.

#### **Course Description**

Concepts, meaning, source, objectives of indirect tax and property tax, legal principles and indirect taxation procedures such as value added tax, specific business tax, stamp duty, excise tax, customs tax, and property tax such as local maintenance tax and land and household tax.

41458 Business Crime (6 credits)

#### **Objectives**

- 1. To acquire the knowledge and understanding on the meaning of business crime.
- 2. To acquire the knowledge and understanding on criminal liability in connection with business.
- 3. To acquire the knowledge and understanding on the laws on financial crime.
- 4. To acquire the knowledge and understanding about measures and mechanism for the suppression of business crime.

# **Course Description**

Meaning of business crime, criminal liability in connection with business, laws on business crime, governmental crime prevention measures and mechanism with emphasis on money-laundering regulations.

#### 41459 Justice Process and Thai Court System

(6 credits)

# **Objectives**

- 1. To acquire the knowledge and understanding on the meaning of civil, criminal and administrative justice process.
- 2. To acquire the knowledge and understanding on agencies in justice process and Thai court system pursuant to the provisions of the Constitution.
- 3. To acquire the knowledge about responsibilities and procedures of the courts.
- 4. To acquire basic knowledge about independent organization and justice process system organization pursuant to the Constitution as well as their responsibilities.

# **Course Description**

Basic knowledge on the meaning of civil, criminal and administrative justice process, agencies in justice process and Thai court system pursuant to the provisions of the Constitution such as Constitutional Court, Courts of Justice, Administrative Court and Martial Court, responsibilities and procedures of those courts in summary, including independent organization and justice process system organization pursuant to the Constitution as well as their responsibilities.

# 41460 Investment Law

(6 credits)

# **Objectives**

- 1. To have fundamental knowledge regarding concepts, theories, and the substance of investment law.
- 2. To understand legal patterns, procedures, and means of different kinds of trade and investment.
- 3. To be able to apply the knowledge and understanding about investment law to consider before investing or doing investing activities.

#### **Course Description**

Concepts, theories, and the substance of investment law for various types of business including role, duties, and liabilities of entrepreneur, rules, regulations, orders, approaches and procedures as stated in the laws, entrepreneur's rights, and the change tendency of business and investment entities.

#### 41461 Administrative Law

(6 credits)

#### **Objectives**

- To provide students with knowledge and understanding about the sources of administrative law and principles of administrative law, structure of administration, management of public officers, administrative of personnel, property and responsibility of administrative and also relation to the control of administrative agencies.
- 2. To provide students with knowledge and understanding about the establishment of structure of Thai and foreign local administrative organizations, and able to explain about administrative liability and control of legality of administrative actions and about fiscal status of local administrative organizations.

#### Course Description

Sources of administrative law, principles of administrative law, juristic persons in public law, administrative action and also legal principle concerning administrative contracts, public service, the administrative of personnel and property responsibility of administrative agencies and legal principles relation to the control of administrative agencies.

The fundamental concept concerning with organization of local administrative, power and duties of these organization, and the regard to public service, the superintendence of such procedures of local administrative organizations.

#### 41462 Public Finance Law

(6 credits)

#### **Objectives**

- 1. To provide students with the knowledge and understanding of basic theories and concepts of monetary and fiscal law, monetary and fiscal policies, as well as the establishment of public finance organizations.
- 2. To provide students with the knowledge and understanding of revenue and expenditure of the government, the public debt structures, and the stage of budget process.
- 3. To provide students with the knowledge and understanding about public spending control and audit, and the monetary and fiscal control.

# Course Description

This course addresses the background, theories and basic concepts of monetary and fiscal law, monetary policies, fiscal policies, public finance organizations, government revenue and expenditure, public debt, budget process, the government spending audit, and the monetary and fiscal control in various forms.
